Memberships are due for renewal on 1 January for the next 12 months

Additional Working bee levy: \$25 for all memberships (except social membership)

Bond for keys held: \$40 only when you have been issued a set.

1. Junior Members must be 17 years and under and over 8 years of age. They must also have at least one Parent/guardian who is a current financial member (Senior or Social) or be a member of a school, which is a current financial member. Parent/Guardian must sign the application for membership. If riding under a school membership – Parent/Guardian signature required as well as school representative signature.
2. Application Forms must be signed – Applicant will not be considered a member until correctly signed
3. Application form is received along with all payable fees.
4. **COMPULSORY** for all members to attend either 2 working bees OR help at 2 official events a year
